The City of Booneville held a work session on March 21, 2022, at 5:30 p.m. at the Booneville City Hall.





The City of Booneville held a work session on February 28, 2022, at 5:30 p.m. at the Booneville City Hall.



The Pledge of Allegiance was led by Alderman Miller.



**MINUTES OF THE SPECIAL CALLED MEETING OF THE MAYOR AND BOARD OF
ALDERMEN OF THE CITY OF BOONEVILLE
March 21, 2022**

BE IT REMEMBERED that the Special Called meeting of the Mayor and Board of Aldermen of the City of Booneville, Mississippi was held on Monday, March 21, 2022, at 4:00 p.m. at City Hall.

Those in attendance were the following: Mayor Chris Lindley, Alderman Jimmy Hicks, Alderman Tara Lauderdale, Alderman Carolyn Miller, Alderman LaVaile Shields and Alderman Jeff Williams. Also present were City Clerk Sharon Williams and City Attorney Daniel Tucker. A quorum was declared present, and the meeting was called to order by Mayor Lindley.

The invocation was given by Alderman Hicks.

The Pledge of Allegiance was led by City Attorney Daniel Tucker.

There first came on for consideration, a request to add to the agenda approving a congratulations ad for the Booneville High School Girls and Boys Basketball teams for winning the State Championship. Alderman Shields made said motion, seconded by Alderman Hicks, and with the Aldermen present and voting Aye, the motion carried.

There next came on for consideration, a request to purchase the congratulations ad from the Banner Independent in the amount of \$125.00. The ad would congratulate the Booneville High School Girls and Boys Basketball teams for winning the State Championship, and would promote the City of Booneville, Mississippi. Alderman Williams made a motion to approve the same, seconded by Alderman Hicks, and with the Aldermen present and voting Aye, the motion carried.

Next, Alderman Williams made a motion to approve to pay Aflac Insurance \$933.39. The motion was seconded by Alderman Lauderdale, and with the Aldermen present and voting Aye, the motion carried.

There next came on for consideration, a request to approve the Banner Independent Advertisement Ad for the Magazine that would run April 28, 2022, again to honor the Girls and Boys Basketball teams for their State title. This would promote the City of Booneville, Mississippi. Alderman Shields made said motion, seconded by Alderman Hicks, and with the Aldermen present and voting Aye, the motion carried.


There next came on for consideration, a request to go into closed session to determine if an executive session was needed to discuss a personnel issue in General Government. Alderman

Williams made said motion, seconded by Alderman Lauderdale, and with the Aldermen present and voting Aye, the motion carried.


While in closed session, it was determined that an executive session could not be held on this matter. Alderman Shields made a motion to go back into open session, seconded by Alderman Lauderdale, and with the Aldermen present and voting Aye, the motion carried.

Next, Alderman Lauderdale made a motion for the Board to find negligence in the mayor's failure to take care of City business. Said motion was seconded by Alderman Shields. Items that were discussed were the Swift Grant for the Park, the ACCO reimbursement check, the Wal-Mart property, the Fred's Building Project, and the Butch Owens' neighborhood petition for services. With a vote of 5 for and 0 against, the Board found the mayor was negligent in taking care of City business.

There being no further business, Alderman Hicks made a motion to adjourn, seconded by Alderman Lauderdale, and with the Aldermen present and voting Aye, the motion carried.
